**LOPEZ CANYON LANDFILL - REVISED SECTION 5 "SOILS CONSTRUCTION QUALITY ASSURANCE" OF THE QA/QC PLAN IN VOLUME IV OF IV REPLACEMENT AMENDMENT TO THE FINAL CLOSURE PLAN**

The Bureau of Sanitation, Solid Resources Disposal and Engineering Division has revised Section 5 of the QA/QC plan in Volume IV of IV "Replacement Amendment to the Final Closure Plan", submitted to your office on June 14, 1996. Section 5 was revised to include testing methods, testing frequencies, and acceptable criteria for the Foundation, Low-Permeability, and Vegetative layers. Attached Section 5 of the QA/QC plan replaces in whole Section 5 in the above mentioned document.

The Bureau would also like to note that only the top 6 to 8 inches of the existing foundation layer will be scarified and recompact. This method has been used on other landfills and has proven to supply an adequate foundation for the low-permeability layer.
