The City of Los Angeles Local Enforcement Agency (LEA) has completed its review of the document titled "Revisions to Volume IV of IV Replacement, Amendment to Final Closure Plan, Lopez Canyon Sanitary Landfill, Lakeview Terrace, California" submitted by the City of Los Angeles Bureau of Sanitation, Department of Public Works.

The document was prepared in response to the CIWMB's October 1, 1996 letter and the LEA's September 29, 1996 letter requesting clarification and additional information on the final closure plan.

The LEA reviewed the submitted responses, the revised Construction Quality Assurance Plan, the additional materials clarifying the final cover design and the potential use of a geosynthetic clay liner (GCL) as an alternative for the low permeability layer. The Bureau of Sanitation has also updated the drawings as requested and also included the proposed energy recovery facility on the drawings.

The LEA considers this final closure plan complete and approved. The Lopez Canyon closure and postclosure documents consist of the following:
