- Post Closure Maintenance Normal operations and maintenance.
- b. Energy Plant and Flare Operation

The power plant generates 3 MW of electricity from the collected methane. Oxygen levels range between 1-2%.

- c. Landscaping / Brush Clearance- Tree Planting / Native Planting Heavy rains, more growth of brush which means it's taking longer to clear.
- d. Environmental Center Mulching and Composting Operation
 Composted most of the last of it, which was communicated by the team
- e. Environmental Education Center -

Every month, LASAN offers free composting workshops, and the public is encouraged to attend.

- f. Equestrian Trails and Trailhead Project Update Maintenance updates. The grand opening of the Horse Trail took place on May 20th, 2023; LASAN will provide the maintenance, including opening and closing the parking lot daily.
- g. Lopez Canyon Green Space Update Groundbreaking is to take place in July 2023; the project includes an upgrade of the playground (ADA compliance), walk path, exercise stations, picnic tables, dog park, and bioswale.

IV. Questions

a. How long after post-closure do you have to monitor? Answer: Monitoring is approximately 30 years or more.

- b. What makes acceptable levels of methane? Answer:
 - i. Does the burning neutralize it? Answer: Lopez power plant neutralizes the collected gas to meet AQMD standards. The flair is only used when the power plants go offline.

- 2. How often is there a leak? Answer: LASAN mitigated and managed the hot spots within the landfill to make sure all potential leaks were sealed. The gas collection system reduces and prevents gas leaks.
- c. What is happening with the dumping on Lopez Road? Answer: The County of Los Angeles cleans the area.
- d. Has any landscaping been done? Answer: Yes, we are hydroseed about an acre with native plants, and we will continue to expand the hydroseeding acreage.
- e. Where are you getting your brush now? Answer: City Crews and private contractors.
- f. Who to contact for their concerns. Answer:.The list of contacts is listed below.
- g. Is this landfill going to attempt to get a permit here to bring the trash? Answer: NO attempt for trash permit.
- h. When will the community be informed of any new processes? Answer: At either a Bi-Annual Meeting or Special Meeting
- i. When will the community be informed about any new pilot program? Answer: At either a Bi-Annual Meeting or Special Meeting
